Keeping our Eyes on the Prize: Single Payer Health Care



Efforts to keep single payer health care on the table continue! Several bills related to Single Payer, Medicare for All, are currently up for consideration in Congress (details below). A new collaboration, Health Care is a Human Right, launched bringing energy to the movement, and the 2015 Single Payer Strategy Conference is bringing together hundreds of advocates next month. While it's unlikely a single payer bill will pass the current Congress, it's still important to continue to advocate for a dramatically improved health care system. Congress and the public need to know that while Medicaid expansion has improved access to care for millions, broader improvements are still needed to resolve an overly complicated system and ensure that quality health care is accessible to everyone.

Single Payer in Congress

These bills currently in Congress propose a Single Payer policy (or bring us closer to one):

H.R. 676: Expanded & Improved Medicare for All Act, introduced by John Conyers Jr. (D-MI13), establishes a Medicare for All Program to provide all individuals residing in the U.S. with health care. The bill restricts participation to public or nonprofit institutions, allowing private insurers to sell benefits not deemed medically necessary and already covered by the bill.

S. 1782 (113th): American Health Security Act of 2013, introduced by Senator Bernie Sanders (D-VT), and H.R. 1200: American Health Security Act of 2015, introduced by Jim McDermott (D-WA7), both aim to create a Medicare for All Single Payer system, recognize health care as a human right, and provide flexibility to states. The bill establishes a state-based program that eliminates



Support Single Payer!

Ask <u>your Representative</u> to cosponsor <u>H.R. 676</u>, <u>H.R. 1200</u>, and <u>H.R. 3241</u>. Be on the lookout for the release of an updated bill for <u>S. 1782</u> and ask your <u>Senators</u> to cosponsor.

End the Caps!

Call your member of congress and tell them "It's time to pass a budget that works for our communities. Please work with your colleagues to raise the spending caps and fully fund community health, housing and supportive service programs."

Call the Congressional Switchboard at (877) 210-5351 to speak with your legislator's office. federally funded health care programs and prohibits the sale of private health insurance that duplicates benefits provided. S. 1782 (113th) is currently being reworked to account for changes under the ACA and is expected to be reintroduced for the 114th Congress.

H.R. 3241: State Based Universal Health Care Act of 2015, introduced by Representative Jim McDermott (D-WA7), amends the Affordable Care Act (ACA) to authorize State-based universal health care systems. Under the ACA, states can create their own form of health care insurance starting on January 1, 2017, otherwise known as a Section 1332 waiver. The waiver provides an opportunity for states to create alternatives such as a public option, but restrictions in the ACA prohibit states from creating a single payer system. A true single payer system includes everyone, and as Vermont's attempt demonstrated, having a system that allows large employers to maintain their insurance and keeps federal health programs like Medicare in place makes a single payer system difficult to implement. H.R. 3241 would remove these barriers and allow states to access federal health care dollars spent on marketplace subside.

Take Action: Support Single Payer by asking <u>your Representative and Senators</u> to cosponsor these bills. Cosponsoring sends a message to other members of Congress that your legislator supports the bill and increases the chance the bill will be moved along in the <u>process of becoming law</u>. 2014 Poverty Data Released

This week the US Census Bureau released <u>2014 data on income, poverty and health insurance coverage</u> showing 46.7 million people, or 14.8% of the population, living in poverty, relatively unchanged from 2013. Notably, the number of persons without health insurance dropped to 33 million, or 10.3%, down from 13.3% in 2013. This data can be a powerful tool to use when advocating on behalf of your programs. Keep Your Voices Raised to End the Spending Caps!



Congress has yet to pass a FY2016 budget and has until September 30 to do so. The options on the table are to pass all <u>12 Appropriations Bills</u> (not likely to happen), pass a <u>continuing resolution</u> (more likely to happen, though uncertain for how long), or let the government shut down and force a compromise. At some point there will be negotiations on the budget. Your congressional members need to hear from you on the importance of <u>funding for programs that support the HCH community</u>. Call your members of Congress and tell them "It's time to pass a budget that works for our communities. Please work with your colleagues to raise the spending caps and fully fund community health, housing and supportive service programs."
